





Violence against Women, Domestic Abuse and Sexual Violence Commissioning Toolkit for Health Boards – Introduction

Aim of toolkit / what the toolkit covers

This toolkit aims to enable and support commissioning within public health boards that meets the needs of survivors of violence against women, domestic abuse and sexual violence (VAWDASV), recognises the importance of VAWDASV specialist services, and understands the context and impact of VAWDASV more widely.

It also outlines public health boards' legal and organisational requirements with regards to VAWDASV and attempts to support them to meet these requirements by providing examples of promising practice that could give inspiration to planning and commissioning similarly designed services.

How to use this toolkit

Health boards can use this toolkit to inform their commissioning plans, by way of reference to ensure they are commissioning the best quality services to survivors of VAWDASV.

This toolkit can also be used to assist health boards to reflect on their own services and to seek opportunities to embed high quality provision to VAWDASV survivors within their daily practice.

The toolkit includes a range of briefings, focusing on specific topics, that are digestible to the audience as well as being informative and evidence based, which will aid strategic planning and commissioning frameworks.

A note about language: we prefer the more positive and empowering term 'survivor', which is used in this toolkit in place of the term 'victim'.
