Project for the Registration of Children as British Citizens (PRCBC)

When supporting a family who has insecure immigration status, it's important to consider what the status and rights of the children are, as well as the parents. Some children will be eligible for British citizenship, even if their parents are not. As usual, such immigration advice needs to be sought from a qualified immigration advisor / lawyer. This can be difficult!

At PRCBC, as well as influencing policy and practice, they run monthly advice surgery slots for young persons who are destitute, isolated or have very limited income; and provide pro bono legal advice and casework for young persons.
